Environmental & Energy Policy

Purpose

Flokk shall be an industry leader within environmental & energy management. Our environmental & energy management system is certified according to ISO 14001:2015 and ISO 50001:2018.

Scope

This Environmental & Energy Policy applies to all employees in the Flokk Group and any subsidiaries. This policy is periodically reviewed and updated.

Owner

Group Management has the overall responsibility to ensure that this policy is complied to, communicated and implemented throughout Flokk, and to ensure sufficient resources to achieve our environmental & energy goals.

Content and description

Based on our three main focus areas - climate, resources and health - we will be an environmentally aware company whose products, services and processes are:

- energy efficient with minimized energy consumption & GHG (greenhouse gas) emissions (carbon footprint)
- resource efficient and leave minimal waste (closed life cycle)
- not hazardous to the environmental and health (reduced use of chemicals)

Flokk shall define, establish and implement an environment & energy management system, annual and long term goals, and ensure continuous improvement of the systems' efficiency. We are committed to minimize our environmental impact, reduce our energy consumption and GHG emission during the whole product lifecycle, and to continuously develop and improve our environmental & energy performance.

We shall commit to increase energy efficiency across the organization, especially in areas such as transport and production. We shall support procurement of energy efficient products and services and design for improvement of energy performance, and we shall have clear and unambiguous environmental requirements for materials and product solutions, and for waste management throughout Flokk's value chain. We will work to achieve relevant eco-labelling of our products, and actively monitor the development in the environmental field.

Flokk will work to prevent, and stay ahead of industry and government requirements for protection of the environment and energy efficiency. As a minimum, we will always comply with local environmental and climate/energy laws where we operate, while proactively work to ensure existing and future compliance obligations globally.
